DEFINITION:

Salesperson shall mean any person who goes from place to place or to a particular place with goods, wares or merchandise for sale or who carries and exposes samples, patterns or specimens of any goods, wares, or merchandise that is to be delivered in the City of Cornwall afterwards. This also includes flea markets.

No such license is required for hawking, peddling, or selling goods, wares or merchandise:

- to wholesale or retail dealers in similar goods, wares or merchandise, or
- if the goods, wares or merchandise are grown, produced or manufactured in Ontario and are hawked, peddled or sold by the grower, producer or manufacturer or its agent or employee having written authority to do so, in the municipality in which the grower, producer or manufacturer resided, or
- if the goods, wares, merchandise are grown or produced by a farmer resident in Ontario who offers for sale or sells only the produce of its own farm, or
- if the goods wares or merchandise are hawked, peddled or sold by an agent of the grower, producer or manufacturer, acting on behalf of a dealer who operates a business within the City of Cornwall and is recognized within the municipal assessment roll as a business operation.
 - i. by persons who sell milk or cream or fluid products to the consumer or to any person for resale, or
 - ii. to persons, organizations, associations or groups who contribute to the enrichment of community life within the City of Cornwall provided that the person, organization, association or group is directly responsible for the retail operation and that all proceeds derived from the sale are used to further the enrichment of community life in the City of Cornwall, or
 - iii. to persons who are licensed under the provisions of the Retail Exhibition Bylaw.

BUSINESS LICENSE

The Licensee(s), at its own expense, shall be required to provide a copy of Certificate of Insurance which includes third party liability in the minimum amount of \$2,000,000.00 inclusive per occurrence for bodily injury (including personal injury, debt, and damage to property including loss of use thereof), and naming The Optimist Club of Cornwall and The Corporation of the City of Cornwall, each, as an additional named insurers on said policy, throughout the term of the Agreement. As well, the Licensee(s), shall provide a receipt of the premium payment, and The Optimist Club of Cornwall will be given ten (10) days' notice in writing of any cancellation, expiration or suspension of the policy or of any reduction in the amount of coverage under the policy.

We are purchasing the Special Events business license permit for you and every vendor to conduct business at this event. The onus is on us to ensure you are in compliance with the permit, as per The Special Events By-law 2015-194.
